

WR Achieved Best Ever Single Day 3 More Pairs Of Special Trains To Run Passing Through Western Railway Via Vasai Road Loading Of Fertilizer On 10th Oct, 2020



Ahmedabad, Western Railway is constantly exploring new avenues to tap the freight traffic at various levels. After achieving the best ever loading in the month of September, 2020, now WR has recorded best ever single day loading of fertilizer on 10th October, 2020. According to a press release issued by Shri Sumit Thakur- Chief Public Relations Officer of Western Rly, further in this direction to boost the freight traffic, one more customer friendly initiative permitting 120 days advance booking of parcel space in various SLRs was initiated. Keeping in line with this scheme, first ever advance booking of SLR was done by Vadodara division for agricultural produce i.e of drum stick, to Howrah. Vadodara division received booking of advance freight of

drumstick to be transported by Train No 02833 Vadodara - Howrah. Four tonnes space has been booked for 75 days, thereby generating revenue of Rs 21.63 lakh. In yet another achievement, Western Railway has recorded best ever single day loading of fertilizers in 31 rakes with 1442 wagons on 10th October, 2020 surpassing previous best of 29 rakes with 1426 wagons achieved on 6th October, 2020.

Shri Thakur stated that. ice 23rd March to 10th Oct, 2020, commodities weighing more than 1.47 lakh tonnes have been transported by Western Rly through its 599 parcel special trains, which mainly included agricultural produce, medicines, fish, milk etc. The revenue generated through this transportation, has been about Rs 49.45 crore. One more accused arrested in Karauli priest death case

Jaipur, The Rajasthan Police on Sunday arrested one more accused in the murder of the priest who was allegedly burnt alive by people angry at his opposition to the encroachment of temple land in state's Karauli district. "The arrested accused has been identified as Dilkhush Meena alias Dhillu. Another accused had been arrested in past and six teams of police are looking for the remaining accused," said a district police official.

On Saturday evening, the family members of the deceased priest had called off their protest after the state government assured them of compensation and action against the accused. Babu Lal Vaishnav, 50, died during treatment for burns at Jaipur's SMS Hospital late on Thursday, a day after Kailash Meena and others from his family allegedly set the priest's hut on fire. In his dying testimony, the priest named six people for setting him on fire, the police said.
